ORDER:

In partial modification of the order issued in the reference read above and in exercise of the powers conferred under sub-clause (ii) of clause (b) of sub section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972, the Registrar of Co-operative Societies, Puducherry hereby appoints **Thiru. E. GUNASEKARAN, Co-operative Officer/ Deputy Registrar (Planning) in-charge** as the **Administrator of the Puducherry Health Employees Cooperative Credit Society Ltd., No.P.475**, with immediate effect, in addition to his normal official duties.

2. The Administrator shall have power to exercise all or any of the functions of the committee and take all such actions as may be required in the interest of the society, given under Sub-Section (2) of the said section subject to the control and such instructions as the Registrar of Co-operative Societies, Puducherry may give from time to time.

3. The Administrator shall take expeditious steps to conduct election to the committee of management of the society.
