Read: Letter No.02/DR/KKL/C/KPSCGS/2018/275 dated 06.10.2025 received from the Deputy Registrar (Karaikal) along with the proposal dated 30.09.2025 of the Karaikal Public Servants Co-operative Credit Society Ltd., No.P. 719, received from the President, along with a copy of Revised Resolution No. 01 dated 14.10.2025 of the committee of management.

ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies, Puducherry, hereby permits the Karaikal Public Servants Co-operative Credit Society Ltd., No.P. 719, Karaikal, to incur an expenditure of not exceeding Rs.1,83,000/- (Rupees one lakh and eighty three thousand only), from the general funds of the society, towards issue of gift coupons to 183 members of the society, worth Rs.1,000/- (Rupees one thousand only) each, enabling them to purchase only from the following cooperative institutions, towards the issue of gift coupons to the members of the society, as detailed below, on the eve of Diwali, 2025.

2) The actual expenditure shall be charged in the accounting year 2024-25 itself and proper account shall be maintained for the issue of gift coupons. Gift coupons shall be issued to enable the members to make purchases from the following co-operative institutions:

1. The Karaikal Public Servants Consumer Cooperative Stores Ltd., No.P.207 (Vanavil), Karaikal.
2. Puducherry State Weavers Cooperative Society Ltd., No.P.57 (PONTEX), Karaikal Branch.
3. The Karaikal Cooperative Milk Producers Union Ltd. No. P. 8 (Colait), Karaikal.
4. The Karaikal Central Cooperative Processing, Supply & Marketing Society Ltd., No.P.15, Karaikal.
