ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies, Puducherry, hereby permits the Karaikal Ministerial Staff Co-operative Credit Society Ltd., No.424, Karaikal, to incur an expenditure of not exceeding Rs.58,000/- (Rupees fifty eight thousand only), from the general funds of the society, towards issue of gift coupons to 58 members of the society, worth Rs.1,000/- (Rupees one thousand only) each, enabling them to purchase only from the following cooperative institutions, towards the issue of gift coupons to the members of the society, as detailed below, on the eve of Diwali, 2025 in commemoration of the International Year of Co-operatives – 2025 (IYC 2025), and in alignment with the cooperative principle of “Co-operation among Co-operatives”.

2. Puducherry State Weavers Cooperative Society Ltd., No.P.57 (PONTEX), Karaikal Branch.

4. The Karaikal Central Cooperative Processing, Supply & Marketing Society Ltd., No.P.15, Karaikal.

2) The actual expenditure shall be charged in the accounting year 2024-25 itself and proper account shall be maintained for the issue of gift coupons.
