ORDER:

In pursuance to the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies hereby permits the Oulgaret Municipality Staff Co-operative Credit Society Ltd., No.P.454 to incur an expenditure of not exceeding **Rs.24,840/- (Rupees twenty four thousand eight hundred and forty only)** or actual expenditure incurred whichever is less from the general funds of the society towards printing of **400 numbers** of monthly-sheet calendar @ **Rs.62.10/-(Including GST)** and distribute the same to the members and to the persons for the development of the society on account of New year 2025.

2. The Printing of Monthly Sheet Calendar should be entrusted to the Puducherry Women Cottage Industrial Cooperative Society Ltd., No.P.23 (Women Press), Puducherry.

3. The actual expenditure shall be charged in the accounting year 2024-25 and proper account shall be maintained for the above said purpose.
