ORDER:

In pursuance to the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Cooperative Societies hereby permits the Puducherry Public Works Department Staff Co-operative Society Ltd., No.P.252 to incur an expenditure of not exceeding **Rs.6,66,930/- (Rupees six lakhs sixty six thousand nine hundred and thirty only)** or actual expenditure incurred whichever is less from the general funds of the society towards printing of **4300 numbers** of Multi-colour monthly-sheet calendar @ **Rs.155.10/-(Including GST)** and distribute the same to the members, associate members, DDO's, Cashiers, VIP's on account of New year 2025.

2. The Printing of Monthly Sheet Calendar should be entrusted to the Puducherry Women Cottage Industrial Cooperative Society Ltd., No.P.23 (Women Press), Puducherry.

3. The actual expenditure shall be charged in the accounting year 2024-25 and proper account shall be maintained for the above said purpose.
