ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the Pondicherry Revenue Staff Cooperative Credit Society Ltd. No.P. 651 to incur an expenditure of not exceeding **Rs.3,99,000/-** (Rupees three lakhs ninety nine thousand only), from the general funds of the society, towards issue of **gift coupon to 399 members** of the society, worth **Rs.1,000/-** (Rupees one thousand only) each, which enables them to make purchase only from the following cooperative institutions:
