ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit **the Puducherry Judicial Staff Cooperative Credit Society Ltd., No.P.502** to incur an expenditure not exceeding **Rs. 5,10,000/-**-(Rupees five lakhs ten thousand only), from the general funds of the society, towards the issue of **gift coupon worth Rs.3000/-** to 170 members of the society and which enables them to make purchases only from the below mentioned cooperative institutions.

- e) The Pondicherry Co-operative Building Centre Ltd.,No.P.544
- f) Pondicherry Cooperative Milk Producers' Union No. P. 1 (Ponlait)
- g) Pondicherry State Co-operative Consumers Federation No. P. 429 (Confed)

2) The actual expenditure shall be charged in the accounting year 2021-22 itself and proper account shall be maintained for the issue of gift coupons.
