Read: Letter dated 22.09.2023 received from the President of the Pondicherry Doordarshan Staff Cooperative Credit Society Ltd., No.P.568, along with a copy of the **Resolution No.2 dated 01.09.2023** of the committee of management.

ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the Pondicherry Doordarshan Staff Cooperative Credit Society Ltd., No.P.568 to incur an expenditure which is restricted to **Rs.52,500/-** (Rupees fifty two thousand five hundred only) against Rs. 56,000/- requested, from the general funds of the society, towards issue of **gift coupons to 35 members** of the society, worth **Rs.1,500/-** (Rupees one thousand five hundred only) each, which enables them to make purchase only from the following cooperative institutions:

- a. Pondicherry Cooperative Wholesale Stores Ltd., No.P.44 (**Amudhasurabi**)
- b. Puducherry State Weavers Cooperative Society Ltd., No.P.57 (**PONTEX**)
- c. Pondicherry Cooperative Handloom Export Development Project Ltd., (**PONFAB**)
- d. Pondicherry Cooperative Building Centre Ltd., No.P.554
- e. Pondicherry Central Cooperative Processing, Supply & Marketing Society Ltd., No.P.31.
- f. Pondicherry Cooperative Milk Producers' Union No. P. 1 (**Ponlait**)
- g. Pondicherry State Co-operative consumers Federation No. P.429 (**Confed**)

2. The actual expenditure shall be charged in the accounting year **2022-23** itself and proper account shall be maintained for the issue of gift coupons.
