12	(i) Authorised Share Capital: The authorised share capital of the society shall be Rs.5,00,00,000/- (Rupees five crores only) made up of 4,99,800 "A" class shares of Rs.100/- each and 2000 "B" class shares of Rs.10/- each.	(i) Authorised Share Capital: The authorised share capital of the society shall be Rs.10,00,00,000/- (Rupees ten crores only) made up of 9,99,800 "A" class shares of Rs.100/- each and 2000 "B" class shares of Rs.10/- each.
