ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the Puducherry Health Employees Cooperative Credit Society Ltd., No.P.475 to incur an expenditure not exceeding **Rs.41,85,400/-** (Rupees Forty one lakhs eighty five thousand and four hundred only), from the general funds of the society, towards the issue of **gift coupon** to the members and associate members of the society, as detailed below, which enables them to make purchases only from the below mentioned cooperative institutions:
