ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the **Health Staff Cooperative Credit Society Ltd., No.P.428** to incur an expenditure of not exceeding **Rs.1,99,200/-** (Rupees one lakh ninety nine thousand two hundred only), from the general funds of the society, towards issue of **gift coupon to 166 members** of the society as detailed below, worth **Rs.1,200/-** (Rupees one thousand two hundred only) each, which enables them to make purchase only from the Karaikal Public servant consumers Cooperative Stores Ltd. P. 207 (Vanavil)
