Sub: The Pondicherry State Co- operative Bank Staff Cooperative Credit Society Ltd., No.P.161 – - Issue of gift coupons to the members for the Year 2025-26 Utilization of general funds - Permission – Accorded.

Read: Letter dated 02.02.2026 received from the President of the Pondicherry State Co- operative Bank Staff Cooperative Credit Society Ltd., No.P.161, along with a copy of the Resolution No.5 dated 23.01.2026.

ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies hereby permits the Pondicherry State Co- operative Bank Staff Cooperative Credit Society Ltd. No.P.161 to incur an expenditure of not exceeding **Rs.3,57,500/- (Rupees three lakhs fifty seven thousand and five hundred only)**, from the general funds of the society, towards issue of **gift coupons to 143 members** of the society, worth **Rs.2,500/- (Rupees two thousand five hundred only)** each, which enables them to make purchase only from the following cooperative institutions:

- h) Karaikal Public servant consumers Cooperative Stores Ltd.P.207 (**VANAVIL**)
- i) Karaikal Cooperative Milk Producers Union Ltd.P.8 (**COLAIT**)
- j) Karaikal Central Cooperative Processing, Supply & Marketing Society Ltd., No.P.15.

2. The actual expenditure shall be charged in the accounting year **2025-26** itself and proper account shall be maintained for the issue of gift coupons.
