ORDER:

In pursuance to the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies hereby permits the Puducherry Health Employees Cooperative Credit Society Ltd., No.P.475 to incur an expenditure not exceeding **Rs.43,70,000/- (Rupees Forty three lakhs seventy thousand only)**, from the general funds of the society, towards the issue of **gift coupon** to the members and associate members of the said society, as detailed below, which enables them to make purchases only from the below mentioned cooperative institutions:
