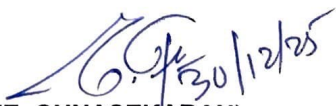
ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under **Rule No. 15** of the subsidiary regulations governing the sanction of **short-term loan** to members of the **Puducherry Public Servants' Co-operative Credit Society Ltd., No.P.52**, the Registrar of Co-operative Societies hereby approves the amendment made to **Rule Nos. 4 & 5(4)** of the said regulations, vide resolution cited and as detailed hereunder. **The said amendment shall take effect from date of issue of this Proceedings.**

Subsidiary regulations governing the sanction of short-term loan to members		
Rule No.	As Existing	As Amended
4	Limit of loan: The maximum amount of loan sanctioned to a member under these regulations shall not exceed Rs.3,00,000/- (Rupees three lakhs only) . Provided that, no member shall be indebted to the society for a sum exceeding Rs.25,00,000/- (Rupees twenty five lakhs only), at any time	Limit of loan: The maximum amount of loan sanctioned to a member under these regulations shall not exceed Rs.5,00,000/- (Rupees five lakhs only) . Provided that, no member shall be indebted to the society for a sum exceeding Rs.25,00,000/- (Rupees twenty five lakhs only), at any time
5(4)	No member shall be eligible to apply for a fresh loan until he/she has fully repaid 50% of the existing loan amount and expiry of 12 months from the date of disbursement of previous loan.	No member shall be eligible to apply for a fresh loan until he/she has fully repaid 50% of the existing loan amount and expiry of 15 months from the date of disbursement of previous loan
