ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies hereby permits the Puducherry Govt. Group B and C Staff Cooperative Credit Society Ltd., No. P. 691 to incur an expenditure of not exceeding **Rs.4,28,000/- (Rupees four lakhs and twenty eight thousand only)** or actual expenditure incurred whichever is less from the general funds of the society towards printing of **2000 numbers** of monthly-sheet calendar @ **Rs.214 /- each (Including GST @ 18%)** and distribute the same to the members, Associate members, DDOs', Cashiers and persons connected with development of the society.

2. The Printing of Monthly Sheet Calendar should be entrusted to the Puducherry Industrial Cooperative Printing Press Ltd., No.P.200 (PIC Press), Puducherry.
3. The actual expenditure shall be charged in the accounting year **2025-26** itself and proper account shall be maintained for the above said purpose
