ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the Pondicherry Cooperative Milk Producers' Union Employees' Cooperative Credit Society Ltd., No.P.374 to incur an expenditure of not exceeding **Rs.15,30,192/-** (Rupees fifteen lakhs thirty thousand one hundred and ninety two only), from the general funds of the said society, towards the disbursement of interest rebate to **505 members** of the said society for the year 2021-22 , **through Electronic Clearing Service (ECS)**, as nine per cent (**9%**) rebate for the interest collected of Rs.1,70,02,085/- during the year 2021-22. The actual expenditure shall be charged in the accounting year 2021-22 itself and proper account shall be maintained for the disbursement of interest rebate.
