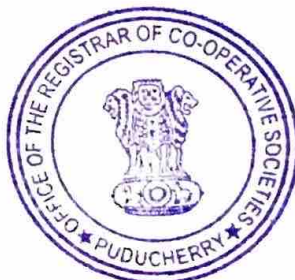
Sub: Eleven primary co-operatives in the consumer section at Puducherry region and Mahe Region – Non-functioning and remains dormant – **Winding up** under Section 126 of the Puducherry Co-operative Societies Act, 1972 – **Orders – Issued.**

Read: This office show-cause notice No.5/8/1/3/RCS/CONS/Misc/2020/127, dated 18.12.2020.

ORDER:-

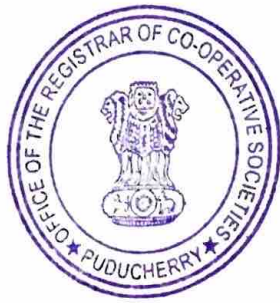
WHEREAS, eleven primary co-operatives in the consumer section at Puducherry region and Mahe region (*for brevity "the societies"*), as listed in the Annexure, were organized by individuals and registered as co-operative societies under the Puducherry Co-operative Societies Act, 1972 (*for brevity "the Act"*).

2) AND WHEREAS, the societies were formed to achieve their objectives for which they were registered. However, it is noticed that, the majority of these societies didn't function at all to achieve their objectives, for which they were registered. Majority of the societies even didn't complete their statutory annual audit of books of accounts and remain dormant for years together. Despite inactiveness, conduct of statutory annual audit of these societies, which is mandatory, is being conducted by officials of this department. Further, at the end every financial year, these societies have to submit annual stock verification report and annual accounts statement to this department. These statutory works consume the precious time and energy of the officials of this department, which could be saved and utilized for other useful and productivity works. It is evident that, for years together these societies didn't function at all for the fulfillment of the objectives specified in the bye-laws of these societies for the promotion of common economic interests of the members of these societies, for which purpose they were started. Hence, it is decided to windup the affairs of the societies under sub-section (2) of Section 126 of the Act;



3) **AND WHEREAS**, an opportunity was given to the societies, **vide reference cited**, to show-cause, within 15 days as to why their affairs shouldn't be wind up. But no reply is received till date;

4) **NOW, THEREFORE**, in view of the above and in exercise of the powers conferred under sub-section (2) of Section 126 of the Puducherry Co-operative Societies Act, 1972, I hereby **direct the winding up of the eleven primary co-operative societies in consumer section at Puducherry region and Mahe region listed in the ANNEXURE, with immediate effect.**

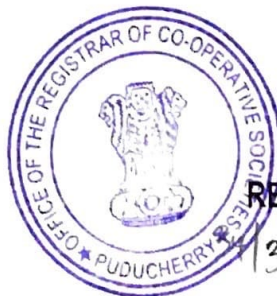
