ORDER

Whereas, it has been brought to the notice of the undersigned that various allegations have been levelled against the management of the three - member committee of the Kalmandabam Co-operative Milk Producers Society Ltd., No. P.301, in respect of (i) appointment of two employees without obtaining prior permission of the competent authority, (ii) failure to conduct election to the Society, and (iii) irregularities in the general functioning of the Society, as reported in the CPGRAMS petition cited under reference;

And Whereas, it is considered expedient to hold an inquiry under Section 75(1) of the Puducherry Co-operative Societies Act, 1972, into the general working of the said three-member committee, particularly with reference to the alleged illegal appointment of two employees, decrease in membership of the Society, non-fixation of fair price for milk supplied by members, non-payment of salaries to employees for the past eight months, and other irregularities as mentioned in the petition;

NOW, THEREFORE, in exercise of the powers conferred under Section 75(1) of the Puducherry Co-operative Societies Act, 1972, the Registrar of Co-operative Societies hereby appoints Thiru P. Muthukumaran, Junior Inspector, to conduct an inquiry into the allegations raised against the said three-member committee.

He shall submit a detailed inquiry report within 15 days from the date of issue of this order.
