Read: Letter dated 15.02.2024 received from the President of The Pondicherry Fisheries Department Staff Cooperative Credit Society Ltd., No.P.218 along with copy of Resolution No.1 dated 14.02.2024 of the committee of management.

ORDER:

WHEREAS, the term of office of the elected committee of management (*for brevity "the committee"*) of the Pondicherry Fisheries Department Staff Cooperative Credit Society Ltd., No.P.218 (*for brevity "the society"*) expires on **31.3.2024**;

2) **AND WHEREAS**, the President of the said society vide reference cited stated that it is difficult to conduct election to the committee of management for the period **1.4.2024 to 31.3.2027** as most of the members are involved in the election duty for the forthcoming Lok Sabha Elections, 2024;

3) **AND WHEREAS**, the President sought for extension of the committee for a period of three months commencing from 01.04.2024;

4) In view of the above, the Registrar of Co-operative Societies satisfied that, as requested by the committee, the term of office of the existing committee is to be extended for a period of three months;

5) **NOW, THEREFORE**, in exercise of the powers conferred under **clause (b) of sub-section (5) of Section 32** of the Puducherry Cooperative Societies Act, 1972, read with **sub-rule (2) of Rule 41** of the Puducherry Cooperative Societies Rules, 1973, **the Registrar of Co-operative Societies hereby extends the term of office of the existing committee of management** of the Pondicherry Fisheries Department Staff Cooperative Credit Society Ltd., No.P.218 **for a period of three months commencing from 01.04.2024**;
