ORDER

WHEREAS winding up under Section 126 of the Puducherry Co-operative Societies Act, 1972 was issued for 20 societies, wherein the Oil and Natural Gas Commission Employees Co-operative Housing Society Ltd., No.P.579 listed at Sl. No. 19, vide proceedings first cited.

AND WHEREAS, the President of the said society has stated, vide letter second cited, that they have launched a layout with 180 plots out of which 53 plots are yet to be registered to the allottees. Further, the society has to claim the compensation amount from the Government of Puducherry for the Land acquisition made for the T.R. Pattinam by pass Road.

AND WHEREAS in view of the reasons put forth by the President of the society, I am satisfied that the winding up proceedings issued to the society is to be revoked;

NOW, THEREFORE, in exercise of the powers conferred on me under Section 131 of the Puducherry Co-operative Societies Act, 1972, I hereby withdraw the winding up order issued vide proceedings first cited (Sl.No.19) in respect of the Oil and Natural Gas Commission Employees Co-operative Housing Society Ltd., No.P.579, and the administration of the said society may be restored to the committee of management which is in force with effect from 01.04.2020
