Sub: Consumer Section – The Puducherry Co-operative Society for Education, Research and Consultancy Services Ltd., No.P.823, Puducherry – Not commenced working – **Winding up** under Section 126 of the Puducherry Co-operative Societies Act, 1972 – **Orders – Issued.**

Read: 1. This office show-cause notice No.5/8/1/5/RCS/CONS/MISC/2017/26, dated 22.02.2023.

2. Letter date 20.03.2023 received from the nominated committee of management of the Puducherry Co-operative Society for Education, Research and Consultancy Services Ltd., No.P.823.

ORDER:-

WHEREAS, a notice was issued vide reference 1st cited, calling the Puducherry Co-operative Society for Education, Research and Consultancy Services Ltd., No.P.823 (**for brevity “the society”**), to state as to why the society should not be wound up under Section 126 (2) of the Puducherry Co-operative Societies Act, 1972 (**for brevity “the Act”**), as it is found that the society has not commenced its working since 07.11.2017. It shows that, the members as well as nominated committee of management are not interested in starting of its working. Moreover, the objects for which the society was registered has been found defeated.

2) **AND WHEREAS**, in reply to the said show cause notice, the nominated committee of management of the Puducherry Co-operative Society for Education, Research and Consultancy Services Ltd., No.P.823, Puducherry vide reference 2nd cited, the society requested to issue necessary orders to start the society is not found to be agreeable.



3) **AND WHEREAS**, the said nominated committee of management fails to submit the proper justification for said show cause notice 1st cited in the reference;

4) **NOW, THEREFORE**, in view of the above and in exercise of the powers conferred under sub-section (2) of Section 126 of the Puducherry Co-operative Societies Act, 1972, I **hereby direct to winding up of the Puducherry Co-operative Society for Education, Research and Consultancy Services Ltd., No.P.823, Puducherry, forthwith and communicate this order to the said society.**
