ORDER

WHEREAS, an election was held on 22.03.2025 to elect six (6) Directors to the committee of management (for short "the committee") of the Mahe Urban Co-operative Society Ltd No. P. 791(for brevity "the Society"), by and from among the members of the society, to hold office from 01.04.2025 to 31.03.2028.

2) AND WHEREAS, in the said election, the following six (6) members of the society were elected as Directors of the society.

3) AND WHEREAS, as per the bye-laws of the society, the committee consists of ten (10) members and the quorum required to function the committee is six (6) Thiru. P. Aravindan, M. No.33, President of the society has been elected for the fourth time and hence becomes disqualified under Sec. 34(2) of the Puducherry Co-operative Societies Act, 1972 whereby, the strength of the committee has fallen below the quorum and hence the committee can no longer function lawfully it would mean that the committee is not functioning properly.

4) AND WHEREAS, in view of the above, it is evident that, due to the said disqualification there is no quorum for the committee:

5) AND WHEREAS, on the above premises, the undersigned has proposed to appoint an Administrator, under Section 33 of the Puducherry Cooperative Societies Act, 1972 (for brevity "the Act"), to manage the affairs of the society;

6) AND WHEREAS, sub-section (1)(b) of Section 33 of the Act provides that, before making an order, the financing bank, viz., the Puducherry State Cooperative Bank Ltd., is to be consulted. Hence, the said financing bank was consulted. The said financing bank consented for the appointment of an Administrator to the society;

7) AND WHEREAS, first proviso to sub-section (1) of Section 33 of the Act provides that, before making an order, a notice shall be published on the notice board of the society inviting objections. The second proviso to sub-section (1) of Section 33 of the Act provides that, it shall not be necessary to publish such notice in case where the Registrar is satisfied that it is not reasonably practicable to do so. As an alternative arrangement has to be made expeditiously.

8) AND WHEREAS, in view of the above facts, the undersigned is satisfied that, there is no other alternative, except that, the said elected committee is to be replaced by an Administrator, to be appointed under Section 33 of the Act;

9) NOW, THEREFORE, in view of the above facts and as an alternative interim arrangement till a new committee is constituted through election and in exercise of the powers conferred on the undersigned under Section 33 of the Puducherry Co-operative Societies Act, 1972, the undersigned hereby appoint Thiru. R. Kangeyan, Deputy Registrar of Co-operative Societies, Mahe as an Administrator of the Mahe Urban Co-operative Society Ltd No. P. 791, in addition to his normal official duties, with immediate effect. Charges handed over to the said Administrator shall be intimated to this office.

10) The said Administrator shall have powers to exercise all or any of the functions of the committee or any other officer of the society as per the Puducherry Co-operative Societies Act, 1972, Puducherry Co-operative Societies Rules, 1973 and Byelaws of the society and take all such actions as may be required in the interest of the society. The Administrator is instructed to conduct election to the Committee of Management within three months time to install a new committee of Management at the earliest.
