PROCEEDINGS OF THE REGISTRAR OF COOPERATIVE SOCIETIES, PUDUCHERRY
(Issued under Section 33 of the Puducherry Cooperative Societies Act, 1972)

Sub: Oulgaret Municipality Staff Cooperative Credit Society Ltd., No.P.454 - Elected committee of management – Expiry of term – Non-conduct of election - **Appointment of Administrator** under Section 33 of the Puducherry Cooperative Societies Act, 1972 – Order – Issued.

Read: This office Circular No.RCS/Planning/Circular/2018/71 dated 26.02.2021 issued by the Registrar of Cooperative Societies.

ORDER:

WHEREAS, the term of office of the elected committee of management (*for brevity "the committee"*) of the Oulgaret Municipality Staff Cooperative Credit Society Ltd., No.P.454 (*for brevity "the society"*) expires on 31.03.2021;

2) AND WHEREAS, in view of the ensuing General Election to the Puducherry Legislative Assembly, 2021 (GEPLA,2021), the registered cooperative societies, functioning in the Union territory of Puducherry were instructed, *vide reference cited*, that, no election and/or polling shall be conducted by any cooperative society to elect new committee of management and/or new office-bearers till the Model Code of Conduct (MCC) is withdrawn by the Election Commission of India (ECI);

3) AND WHEREAS, committees, whose term expires on 31.03.2021, have requested to extend their term of office for a period of three (3) months commencing from 01.04.2021. But, the committee of the society didn't make any request to extend its term of office;

4) AND WHEREAS, in view of the above facts, I am satisfied that, there is no other alternative except that the said elected committee of the society is to be replaced by an Administrator, under Section 33 of the Puducherry Cooperative Societies Act, 1972 (*for brevity "the Act"*) to manage the affairs of the society till election is conducted to install a new committee;



5) AND WHEREAS, sub-section (1)(b) of Section 33 of the Act provided that, before making an order, the financing bank, viz., the Puducherry State Cooperative Bank Ltd., is to be consulted. Hence, the said financing bank was consulted. The said financing bank consented for the appointment of an Administrator to the society;

6) AND WHEREAS, first proviso to sub-section (1) of Section 33 of the Act specifies that, before making an order, a notice shall be published on the noticeboard of the society inviting objections. The second proviso to sub-section (1) of Section 33 of the Act specifies that, it shall not be necessary to publish such notice in case where the Registrar is satisfied that it is not reasonably practicable to do so. As alternative arrangements are to be made expeditiously and lack of sufficient time to publish a notice, I have decided to dispense with the publication of the said notice.

7) **NOW, THEREFORE**, in view of the above and in exercise of the powers conferred on me under Section 33 of the Puducherry Cooperative Societies Act, 1972, I hereby appoint **Thiru K.Dhanabalan, Cooperative Officer / Liquidator, as the Administrator of the Oulgaret Municipality Staff Cooperative Credit Society Ltd., No.P.454, in addition to his normal official duties, with effect from 1st April, 2021 (01.04.2021).** Charges of the society handed over by the President of the society and taken over by the said Administrator are to be intimated to this office.

8) The said Administrator shall, subject to my control and to such instructions as I may, from time to time, give, have powers to exercise all or any of the functions of the committee or any other officer of the society and take all such actions as may be required in the interest of the society.

9) ***The said Administrator is directed to arrange to conduct the election, after revocation of MCC by the ECI, to install a new committee for the society.***
