Vide notice No.5/5/1/5/RCS/Hdlms/B3 /2013/174, dated 11.12.2020.

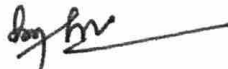

ORDER:-

WHEREAS, a notice was issued vide reference 1st cited, calling Villianur Weavers Co-operative Society Ltd., No. P-324 (*for brevity "the society"*), to state as to why the society should not be wound up under Section 126 of the Puducherry Co-operative Societies 1972, as it is found that the Society was running on loss and the activities of the society become defunct and further there appears no scope for the survival or for revival of its activities.

2) AND WHEREAS, show cause notice and reminder letters sent to the Administrator of the Society vide reference 2nd cited with a request to submit the reply within 30 days failing which action will be initiated without further notice. But no reply is received by this office even after the lapse of nearly nine months.

3) **NOW, THEREFORE**, in view of the above and in exercise of the powers conferred under sub-section (1) of Section 126 of the Puducherry Co-operative Societies Act, 1972, I hereby direct the winding up of the Villianur Weavers Co-operative Sty Ltd No. P- 324 with immediate effect.
