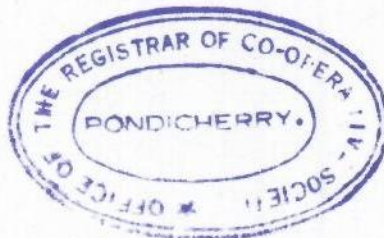
Sub: Oulgaret Municipality Staff Cooperative Credit Society Ltd., No.P.454 - Amendment made to bye-law No.32(1) - Registration under Section 11 of the Puducherry Coop. Societies Act, 1972 – Order – Issued.

Read: (1) G.O.Ms.No.21/Coop dated 18.11.1992 of the Chief Secretariat (Cooperation & Community Development), Government of Puducherry.
(2) This office show-cause notice No.RCS/Planning/Emp.Cr./No.P.454/2020/169 dated 15.12.2020 of the Registrar of Cooperative Societies.
(3) This office letter No. No.RCS/Planning/Emp.Cr./No.P.454/2020/1 dated 06.01.2021.
(4) Letter dated 04.03.2021 received from the President of the Oulgaret Municipality Staff Cooperative Credit Society Ltd., No.P.454, along with a copy of **Resolution No. 6** dated 17.02.2021 of the General Body of the society.

ORDER:

In order to remove the existing disproportionate division of constituencies in the committee of management of the Oulgaret Municipality Staff Cooperative Credit Society Ltd., No.P.454 (**for short the society**”), it was proposed to directly amend the bye-law No.32(1) of the society in exercise of the powers conferred under the Section 12 of the Puducherry Cooperative Societies Act, 1972. An opportunity was given to the society, **vide reference 2nd cited**, to show-cause as to why the said bye-law shouldn't be directly amended and registered by the Registrar of Cooperative Societies. The President of the society was once again requested, vide reference 3rd cited, to arrange to convene the General Body meeting of the society to discuss and decide the proposal of amendment of the said bye-law.

2) On examination of the **reference 4th cited** and in exercise of the powers conferred on me vide reference 1st cited, I **register the amendment of bye-law No. 32(1), made by the General Body of the Oulgaret Municipality Staff Cooperative Credit Society Ltd., No.P.454**, vide resolution cited and as detailed in the **Annexure**. The said amendment shall come into force from the date of issue of this proceeding.

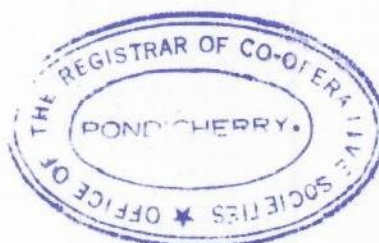
