(Issued under Section 129 of the Puducherry Co-operative Societies Act, 1972)

Sub: Consumer Section – The Puducherry Co-operative Society for Education, Research and Consultancy Services Ltd., No.P.823, Puducherry – Cancellation of registration – Order under Section 129 of the Puducherry Co-operative Societies Act, 1972 – Issued.

Read: This office proceedings No.5/8/1/5/RCS/CONS/MISC/2017/76, dated 30.05.2023.

ORDER:-

WHEREAS, a winding up order was issued vide reference cited, the Puducherry Co-operative Society for Education, Research and Consultancy Services Ltd., No.P.823 (**for brevity “the society”**), the society has not commenced its working since 07.11.2017. It shows that, the members as well as nominated committee of management are not interested in starting of its working. Moreover, the objects for which the society was registered has been found defeated.

2) **AND WHEREAS**, no transactions were made by the society and the society has been collected the share suspense amount from the proposed members of the society. It should be approved by the first general body meeting of the society. But the said society has not convened the first general body meeting and also has not started its working. Hence, the society was wound up under Section 126 of the Puducherry Co-operative Societies Act, 1972 (**for brevity “the Act”**) vide reference cited.

3) **NOW, THEREFORE**, in view of the above and in exercise of the powers conferred under Section 129 of the Puducherry Co-operative Societies Act, 1972, I hereby make an order cancelling the registration of the Puducherry Co-operative Society for Education, Research and Consultancy Services Ltd., No.P.823, Puducherry and henceforth, on cancelling of its registration the said society shall cease to exist from the date of such order of cancellation.
