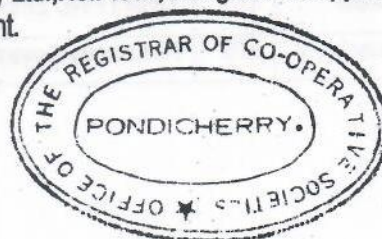

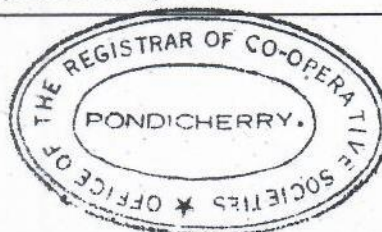

WHEREAS, the term of office of the elected committee of management (*for brevity "the committee"*) of the following eighteen (18) Employees' Cooperative Credit Societies (*for brevity the "societies"*) expires on 31.03.2021;

2) AND WHEREAS, in view of the ensuing General Election to the Puducherry Legislative Assembly, 2021 (GEPLA, 2021) the registered cooperative societies, functioning in the Union territory of Puducherry were instructed, *vide reference 19th cited*, that, no election and/or polling shall be conducted by any cooperative society to elect new committee of management and/or new office-bearers till the Model Code of Conduct (MCC) is withdrawn by the Election Commission of India (ECI);

3) AND WHEREAS, the committee of the societies have requested, *vide references 1st to 18th cited*, to extend their term for a period of three (3) months, six (6) months or one (1) year, as the case may be;

4) AND WHEREAS, in view of GEPLA, 2021 and due to existence of MCC, it is not possible to conduct election in the said cooperative societies;

5) AND WHEREAS, in view of the above, I am satisfied that, the term of office of the committee of management of the societies are to be extended for a period of three months in as much as under the provisions of the Puducherry Cooperative Societies Act, 1972 and the Rules made thereunder, maximum period of extension of term of office of the committee of management of societies shall not exceed six (6) months in aggregate and three (3) months at any one time.

6) NOW, THEREFORE, on the above premises and due to existence of MCC in respect of GEPLA, 2021 and in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of the Puducherry Cooperative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Cooperative Societies Rules, 1973, I extend the term of office of the existing elected committee of management of the above said eighteen (18) Nos. of Employees' / Staff Cooperative Credit Societies for a period of three (3) months commencing from 01.04.2021.

7) *The committee of management of the said societies are directed to arrange to conduct their elections, after revocation of MCC by the ECI and before the expiry of their extended term, to install a new committee with effect from 01.07.2021.*

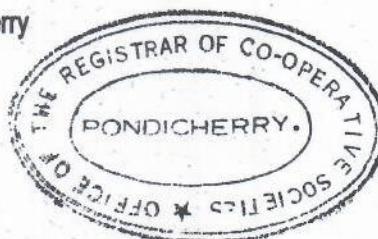
