Read : Proceedings No.5/7/4/12/RCS/Dairy/2024/87 dated 28.10.2024 of the Registrar of Co-operative Societies, Puducherry.

ORDER:

In partial modification of the proceedings cited and in exercise of the powers conferred under sub-section(1) of Section 33 of the Puducherry Cooperative Societies Act, 1972, the undersigned hereby appoint a three members committee consisting of the following members to manage the affairs of the Ariyur Co-operative Milk Producers' Society Ltd., No.P.268, with immediate effect.

Thiru.M.Ilangovane, M.No.838, shall act as the **President** of the said committee. The committee shall have powers to exercise all or any of the functions of the committee or any officer of the said society and to take all such action as may be required in the interest of the society, subject to the control of the undersigned with following instructions and to such instructions as may be given from time to time under sub section (2) of the said section.



Contd/-

- i. The three-member committee should arrange to complete election to the committee & management within six months from the date of assumption of charges;
- ii. The three-member committees should not take any policy decision, which may affect the financial position of the society, without prior permission of the Registrar of Co-operative Societies;
- iii. The three-member committee should not engage or appoint any staff / remove or regularization of any staff, without prior permission of the Registrar of Co-operative Societies;
- iv. The three-member committee should not either re-instate the staff who is under suspension, or place any one under suspension, without prior permission of the Registrar;

The three-member committee should invariably adhere the above said instructions, without any lapses. It may be noted that violation of the above said instructions, if any will be liable for legal action in accordance with law.
