**ORDER:**

**WHEREAS**, the term of office of the elected committee of management (*for brevity "the committee"*) of LIC Staff Co-operative Credit Society Ltd., No.P.178 (*for brevity "the society"*) expires on **31.03.2025** ;

**2) AND WHEREAS**, the President of the said society vide reference cited stated that it is difficult to conduct election to the committee of management for the period **01.04.2025 to 31.3.2028** as per Section 32 (5) (a) of the Puducherry Cooperative Societies Act, 1972 as the members are busy with the year end work, to achieve and to complete the targets and are not having ample time to conduct election to the committee of management within 31.3.2025 and managed without any paid staff ;

**3) AND WHEREAS**, the President sought for extension of the committee for a period of three months commencing from 01.04.2025;

**4)** In view of the above, the Registrar of Co-operative Societies is satisfied that, the term of office of the existing committee has to be extended for a period of three months;

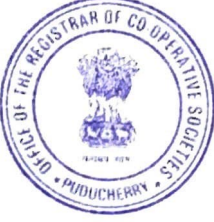
