4) **NOW, THEREFORE**, in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of the Puducherry Cooperative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Cooperative Societies Rules, 1973, **the undersigned extend the term of office of the existing elected committee of the Mettacuru Adi-Andhra Agricultural Field Labourers Co-operative Society Ltd., No.P.484, Yanam for a period of three (3) months commencing from 01.07.2023 to 30.09.2023.**

5) **The committee of management of the said society is directed to arrange to conduct the elections, before the expiry of the extended term and bring to a new committee with effect from 01.10.2023.**
