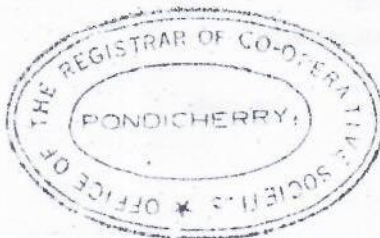

ORDER:

WHEREAS, a "3 Member Committee" was appointed, *vide reference cited*, to manage the affairs of the Karaikal Judicial Staff Cooperative Credit Society Ltd., No.P.473 (for short the "society");

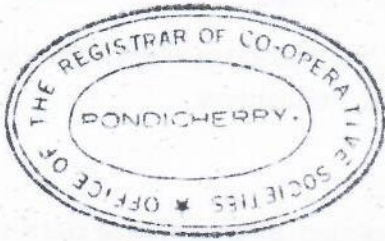
2) AND WHEREAS, the Secretary to Government (Cooperation) directs that, cooperative societies should be managed only by elected committee of management. Despite repeated requests, the said 3 Members Committee remains reluctant to conduct election to elect a new committee of management for the society;

3) AND WHEREAS, in view of the above and in order to conduct election, the undersigned decided to appoint an Administrator to manage the affairs of the society in lieu of the said 3 Members Committee;



3) **NOW, THEREFORE**, in view of the above and in order to conduct election to the society and in exercise of the powers conferred on me under Section 33 of the Puducherry Cooperative Societies Act, 1972, I hereby appoint Thiru M.Ravanan, Cooperative Officer/ Managing Director, Karaikal Coop. Milk Producers' Union Ltd., as the Administrator of the Karaikal Judicial Staff Cooperative Credit Society Ltd., No.P.473 with immediate effect.

4) The said Administrator is directed to arrange to conduct election to the committee of management of the society, as early as possible, positively within a period of one month from the date of assumption of charges of the society. Charges of the said society handed over and taken over shall be informed to this office.
