**ORDER**

WHEREAS, the term of the existing Committee of Management of the Pondicherry Municipality & Commune Panchayat Employees Co-operative Housing Society Ltd. No .P. 521 was extended upto 31.12.2020 vide reference 2<sup>nd</sup> cited;

2. AND WHEREAS, the existing committee failed to conduct election to the committee of management before the expiry of the extended period;

3. AND WHEREAS, in view of the reason, stated above and in order to manage the day to day affairs of the society, an alternative arrangement is to be made and therefore action under Section 33(1) of the Puducherry Co-operative Societies Act, 1972 is essential and I have decided on my own motion, to appoint an Administrator, to manage the affairs of the said society till a new committee enters upon office;

4. AND WHEREAS, the undersigned is also satisfied that it is not reasonably practicable a publish notice, inviting objections to the said proposal as required under the provisions of sub-section (1) of section 33 of the Puducherry Co-operative Societies Act, 1972, as an alternative arrangement is to be made expeditiously to manage the affairs of the said society;

5. NOW, THEREFORE, in view of the above and in exercise of the power conferred on me under sub section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint **Thiru. A. Rathinakumar Senior Inspector (Audit), Co-operative Department, Puducherry**, as Administrator of the Pondicherry Municipality & Commune Panchayat Employees Co-operative Housing Society Ltd., No. P. 521, Puducherry with immediate effect, in addition to his normal duties, till a new committee enters upon office.

6. The Administrator should take action to conduct election to the committee of management of the Pondicherry Municipality & Commune Panchayat Employees Co-operative Housing Society Ltd., No. P. 521, as early as possible;

The Administrator shall exercise all the functions of the committee subject to my control and to such instructions as I may, from time to time give, have powers to exercise all or any of the functions of the committee or any officer of the society and take all such action as may be required in the interest of the society under sub section (2) of the section 33 of the said Act.
