PROCEEDINGS OF THE REGISTRAR OF COOPERATIVE SOCIETIES, PUDUCHERRY

Present: Tmt. SMITHA.R

Registrar of Cooperative Societies, Puducherry.

Sub: Uruvaiyaru Cooperative Milk Producers' Society Ltd., No. P.266 – Committee of management – Defunct - Restoration of normalcy - Appointment of Administrator under Section 33 of the Puducherry Cooperative Societies Act, 1972 - Order Issued.

ORDER:

WHEREAS an election was conducted to the committee of management (*for short "the committee"*) of the Uruvaiyaru Cooperative Milk Producers Society Ltd., No.P.266 (*for short "the society"*) and the following nine members of the society were elected to the committee to hold office for a period of three years from 01-07-2018 to 30-06-2021:-

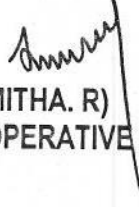
- 2) AND WHEREAS, it was reported that, the President of the society disqualified two members of the committee, viz., Tvl. (1) A.Mahadevan S/o. Arumugam and (2) V.Lenin S/o. Veerabathraan, **vide Resolution dated 21-10-2019** in as much they didn't attend four consecutive meetings of the committee;
- 3) AND WHEREAS, it was further reported that, five members of the committee, including the above said disqualified two members of the committee, removed the President of the society and elected Tmt. L.Meera, as the new President of the society, **vide Resolution No.1 dated 26.11. 2019**. It was also resolved to authorise the said Tmt. L.Meera and the Secretary of the society Tmt. S.Rajeswari to jointly operate the Bank accounts of the society;
- 4) AND WHEREAS in the meeting of the committee held on 05.12.2019, Thiru P.Gnanavel (M.No.848) and Tmt. M.Sithravalli (M.No.1002) were co-opted, **vide Resolution No.2 dated 05.12.2019**, as members of the committee. I am of the view that, the above-stated three resolutions lack legal validity;
- 5) AND WHEREAS, it was also reported that, Tmt. S.Rajeswary, Secretary of the society was suspended from service by the President of the society;
- 6) AND WHEREAS, the Cooperative Officer (Dairy) conducted a discreet inquiry on 18.12.2019 and reported the following:
- a) The society maintains heavy cash balance of Rs.51,506/- as on 17.12.2019 and the same was not produced for verification.
 - b) The Minutes book was not produced for verification.
 - c) Meetings of the committee was not convened in accordance with the provisions of bye-laws No.18 of the bye-laws of the society.
 - d) Milk payment is not made regularly to the members of the society once in a fortnight.
- 7) AND WHEREAS, on perusal of the records available and the findings of the above-said inquiry, I am of the view that, the committee doesn't function properly in accordance with the registered bye-law of the society, the Puducherry Cooperative Societies Act, 1972 and the Rules made thereunder;
- 8) AND WHERAS, in view of the reasons stated above, I am of the opinion that, the committee is to be replaced by an Administrator to be appointed under Section 33 of the Puducherry Cooperative Societies Act, 1972;
- 9) AND WHEREAS, I am satisfied that, it is not reasonably practicable to publish a notice, inviting objections to the said proposal, as required under the provisions of sub section (1) of section 33 of the

Pondicherry Cooperative Societies Act, 1972, as an alternative arrangement is to be made expeditiously to manage the affairs of the said society;

10) **NOW, THEREFORE**, in view of the above factual information and in order to restore normalcy in the functioning of the society and in the interest of the members of the society and in exercise of the powers conferred on me under sub-section (1) of Section 33 of the Pondicherry Cooperative Societies Act, 1972, I hereby appoint **Thiru C.Saravanane, Cooperative Officer (Audit)** as the Administrator to manage the affairs of the Uruvaiyar Cooperative Milk Producers' Society Ltd., No.P.266, vice the elected committee of management, with immediate effect, in addition to his normal duties, till a new committee enters upon office.

11) The Administrator, shall exercise all the functions of the committee, subject to my control and to such instructions as I may, from time to time give, have powers to exercise all or any of the functions of the committee or any officer of the society and take all such action as may be required in the interest of the society under sub section (2) of the section 33 of the said Act.

12) The said Administrator shall arrange to conduct election to the committee of management of the society, as early as possible, positively before 30.04.2020.
