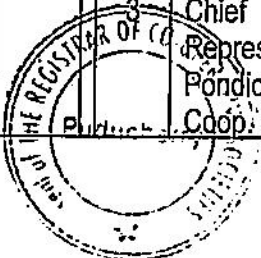

ORDER:

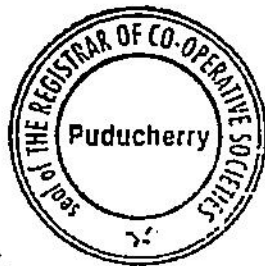
