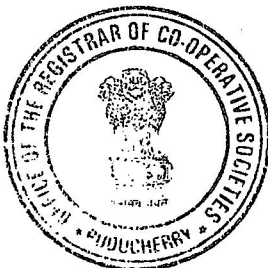
ORDER:

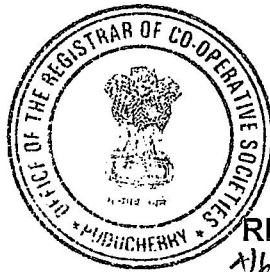
