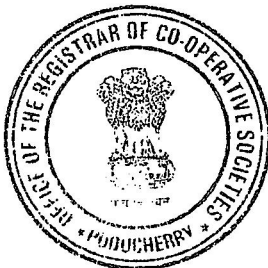
ORDER:

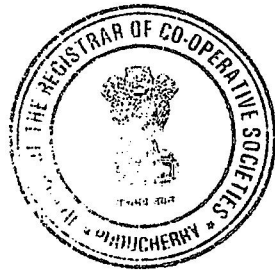
