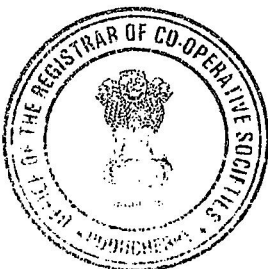
ORDER:

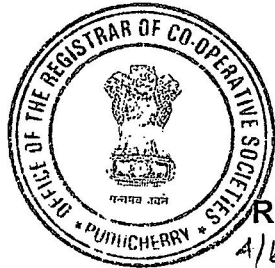
