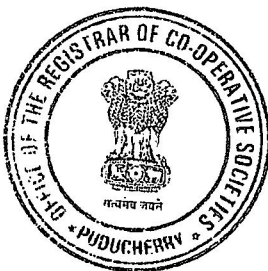
ORDER:

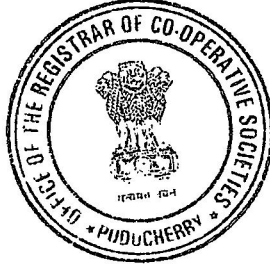
