(2) Resignation letter dated 09.09.2020, received from Tmt. R. Selvi, W/o. Rajendiran, M.No.296, member of the Three Member Committee.

ORDER:

WHEREAS, Thiru. S. Govindan, S/o. Seshasalam M.No.394, **Thiru. M. Manivannan,** S/o. Murugesan, M.No. 93, and **Tmt. R. Selvi,** W/o. Rajendiran, M.No.296 were appointed as members of the Three Member Committee of the Sellipet Co-operative Milk Producer's Society Ltd., No.P-265 under Section 33(1) of the PCS Act, 1972 to manage the affairs of the said society vide Proceedings of Registrar of Co-operative Societies cited under 1st reference;

AND WHEREAS, out of the three members of the committee stated above, **Tmt. R. Selvi,** W/o. Rajendiran, M.No.296 had tendered resignation to her post of member of the Three Member Committee to the Registrar on 09.09.2020 stating some irregularities found in the said society;

AND WHEREAS, consequent on the resignation of one member in the Three Member Committee, the strength of the committee has come down to 2(two) members and had fallen below the quorum of Three and it is felt that the society could not be able to function and carry on the activities;

AND WHEREAS, in view of the reasons stated above, the undersigned is of the opinion that the Three Member Committee of the Sellipet Cooperative Milk Producers' Society Ltd., No.P. 265 cannot function and conduct committee meetings and manage the affairs of the society;

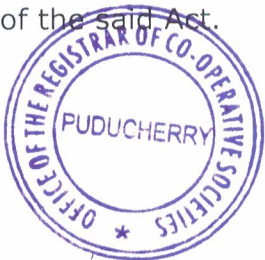
AND WHEREAS, in view of the above reasons, I have decided, on my own motion, to appoint an Administrator, to manage the affairs of the said society till a new committee enters upon office;

AND WHEREAS, the undersigned is also satisfied that it is not reasonably practicable to publish a notice, inviting objections to the said proposal, as required under the provisions of sub section (1) of section 33 of the Puducherry Cooperative Societies Act, 1972, as an alternative arrangement is to be made expeditiously to manage the affairs of the said society;

NOW, THEREFORE, in view of the above and in exercise of the powers conferred on me under sub section (1) of section 33 of the Puducherry Cooperative Societies Act, 1972, I hereby appoint **Thiru R.Indiramogane, Senior Inspector (Audit Section), as Administrator of the Sellipet Cooperative Milk Producers' Society Ltd., No.P.265, with immediate effect in addition to his normal duties with an instruction to arrange to conduct election and form a elected committee of management at the earliest.**

The Administrator, shall exercise all the functions of the committee, subject to my control and to such instructions as I may, from time to time give, have powers to exercise all or any of the functions of the committee or any officer of the society and take all such action as may be required in the interest of the society under sub section (2) of the section 33 of the said Act.
