ORDER:

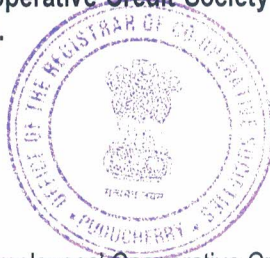
