PROCEEDINGS OF THE REGISTRAR OF COOPERATIVE SOCIETIES, PUDUCHERRY

(Issued under Section 33 of the Puducherry Cooperative Societies Act, 1972)

 Appointment of Administrator – Order under Section 33 of the of the Puducherry Cooperative
 Societies Act, 1972 – Issued.

ORDER:

WHEREAS, the term of office of the committee of management (*for brevity "the committee"*) of the
 Pondicherry Distilleries Employees' Cooperative Credit Society Ltd., No.P.384 (*for brevity "the society"*) expired
 on 31.03.2020;

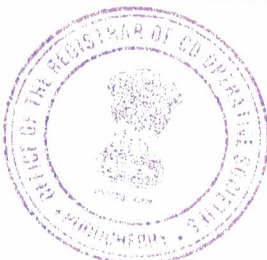
2) AND WHEREAS, polling scheduled on 30.03.2020 to elect a new committee was not conducted due to
 COVID-19. Based on the committee's request and due to COVID-19, the term of the committee was extended
 twice, *vide references 1st and 2nd cited*, for a period of three (3) months commencing from 01.04.2020 to
 30.06.2020 and 01.07.2020 to 30.09.2020 respectively;

3) AND WHEREAS, due to COVID-19, the committee requested, *vide resolution 3rd cited*, to extend its
 term for a further period of three months commencing from 01.10.2020;

4) AND WHEREAS, Section 32(5)(b) of the Puducherry Cooperative Societies Act, 1972 empowers me to
 extend the term of an elected committee only for a maximum period of six months, and hence, extension is not
 possible beyond the period of six months;

5) AND WHEREAS, in view of the above, I am satisfied that, there is no other alternative except that the
 committee is to be replaced by an Administrator to be appointed under Section 33 of the said Act to manage the
 affairs of the society till pending election process is completed to install a new committee;

6) AND WHEREAS, Section 33(1)(b) of the said Act specifies that, before making an order, the financing
 bank, viz., Puducherry State Cooperative Bank Ltd., is to be consulted. Even though the society is not indebted to
 the said financing bank, the financing bank was consulted. The said financing bank consented for the appointment
 of an Administrator to the society;

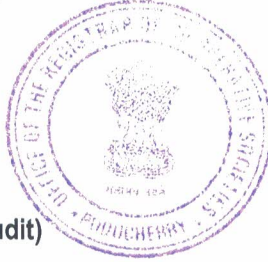


7) AND WHEREAS, the first proviso to Section 33(1) of the said Act specifies that, before making an order, a notice shall be published on the notice board of the society inviting objections, whereas, the second proviso specifies that, it shall not be necessary to publish such notice in case where the Registrar is satisfied that it is not practicable to do so. As alternative arrangements are to be made expeditiously and due to lack of sufficient time to publish such notice, I have decided to dispense with the publication of the said notice.

8) **NOW, THEREFORE**, in view of the above and as an interim arrangement and in exercise of the powers conferred on me under Section 33 of the Puducherry Cooperative Societies Act, 1972, I hereby appoint Thiru K.Srinivasan, Cooperative Officer (Audit) as the Administrator of the Pondicherry Distilleries Employees' Cooperative Credit Society Ltd., No.P.384, in addition to his normal official duties, with effect from 1st October, 2020 (01.10.2020). Charges handed over and taken over are to be intimated to this office.

9) The said Administrator shall, subject to my control and to such instructions, as I may, from time to time, give, have powers to exercise all or any of the functions of the committee or any other officer of the society and take all such actions as may be required in the interest of the society.

10) Subject to the guidelines / instructions of the Government of Puducherry in respect of COVID-19, the said Administrator shall arrange to complete the pending polling to install a new committee as early as possible.
