PROCEEDINGS OF THE REGISTRAR OF COOPERATIVE SOCIETIES PUDUCHERRY

(Issued under Section 127 of the Puducherry Cooperative Societies Act, 1972)

Present: Tmt. SMITHA.R, I.A.S.
Registrar of Cooperative Societies, Puducherry.

Sub: 20 numbers of primary cooperative housing societies - Non-functioning and remains dormant – Winding up - Appointment of Liquidators under Section 127 of the Puducherry Cooperative Societies Act, 1972 – Order – Issued.

Read: Proceedings No.RCS/Housing/Liquidation/2020/88 dated 30.06.2020 the Registrar of Cooperative Societies, Puducherry.

ORDER:

WHEREAS, an order was made, *vide reference cited*, directing the winding up of the affairs of twenty (20) numbers of the primary cooperative housing societies (*for brevity "the societies"*), listed in the Annexure,

2) AND WHEREAS, consequent to the winding up of the society, a Liquidator is to be appointed, under sub-section (1) of Section 127 of the Puducherry Cooperative Societies Act, 1972 (*for brevity "the Act"*), in consultation with the financing bank, to carry out the liquidation processes for cancelling the registration of the society;

3) AND WHEREAS, the financing bank, viz., Pondicherry State Cooperative Bank Ltd., was consulted in respect of the proposal of appointing a Liquidator for the societies and the said Bank consented for the said proposal.

4) NOW, THEREFORE, in exercise of the powers conferred on me under sub-section (1) of Section 127 of the Puducherry Cooperative Societies Act, 1972, read with clause (a) of Rule 66 of the Puducherry Cooperative Societies Rules, 1973, I hereby appoint (a) Thiru K.Dhanabalan, Cooperative Officer, as the Liquidator of the eighteen (18) numbers of primary cooperative housing societies (Puducherry region) listed in the Annexure (b) Thiru P.Savarirajalu, Senior Inspector, Karaikal as the Liquidator of the Oil & Natural Gas Commission Employees' Cooperative Housing Society Ltd., No.P.579 and (c) Thiru Mohammed Abdul Razaq, Senior Inspector, Yanam as the Liquidator of the Regency Employees' Cooperative Housing Society Ltd., No.P.625, Yanam.

5) The President / Administrator of the societies are directed to handover the charges of their societies concerned to the said Liquidator. Charges of the societies handed over and taken over shall be informed to this office.

6) On taking over of charges of the societies, the said Liquidators shall arrange to discharge the liabilities of the societies subject to availability of funds from the realizable assets of the societies at the earliest possible. On completion of the liquidation process, the said Liquidators shall submit report to the undersigned to make an order for the cancellation of registration of the societies under Section 129 of the said Act.
