ORDER:

WHEREAS, Thiru P.Patcheappan (Member No.3692) was disqualified, *vide reference 1st cited*, to hold office as a member of the committee of management (*for brevity "the committee"*) of the Puducherry Public Works Department Staff Cooperative Society Ltd., No.P.252 (*for brevity "the society"*);

2) AND WHEREAS, a notice dated 30.10.2019 was issued, *vide reference 2nd cited*, directing the said Thiru P.Patcheappan and the society to show-cause, within ten days, as to why the said Thiru P.Patcheappan shouldn't be removed from the committee of the society. The society submitted its response, *vide reference 3rd cited*. Despite the receipt of the said notice on 31.10.2019, the said Thiru P.Patcheappan didn't response.

3) NOW, THEREFORE, in exercise of the powers conferred under Rule 46 the Puducherry Cooperative Societies Rules, 1973, I hereby remove the said Thiru P.Patcheappan from the committee of management of the Puducherry Public Works Department Staff Cooperative Society Ltd., No.P.252 with immediate effect.
