ORDER

WHEREAS, the term of office of the committee of management of the Hindustan Unilever Limited Employees Co-operative Thrift and Credit Society Ltd., No.P. 796 expired on 30.6.2013;

AND WHEREAS, the committee had not conducted election to elect a new committee before expiry of its term of office;

AND WHEREAS, in view of the above, I am of the opinion that an Administrator is to be appointed forthwith to manage the affairs of the society;

AND WHEREAS, I am satisfied that it is not reasonably practicable to publish a notice on the notice board of the society, inviting objection on the proposal of appointment of an Administrator, as alternative arrangements are to be made expeditiously;

AND WHEREAS, the financing bank, viz. the Pondicherry State Co-operative Bank Ltd was consulted in the matter of appointment of Administrator to the said society and the said bank has no objection to the proposal of appointment of Administrator;

NOW, THEREFORE, in exercise of the powers conferred on me under sub-section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint Thiru K. SRINIVASAN, Senior Inspector (Planning), as Administrator of the Hindustan Unilever Limited Employees Co-operative Thrift and Credit Society Ltd., No.P. 796 with effect from 1.7.2013, in addition to his normal duties, till a new committee enters upon office.
