ORDER:

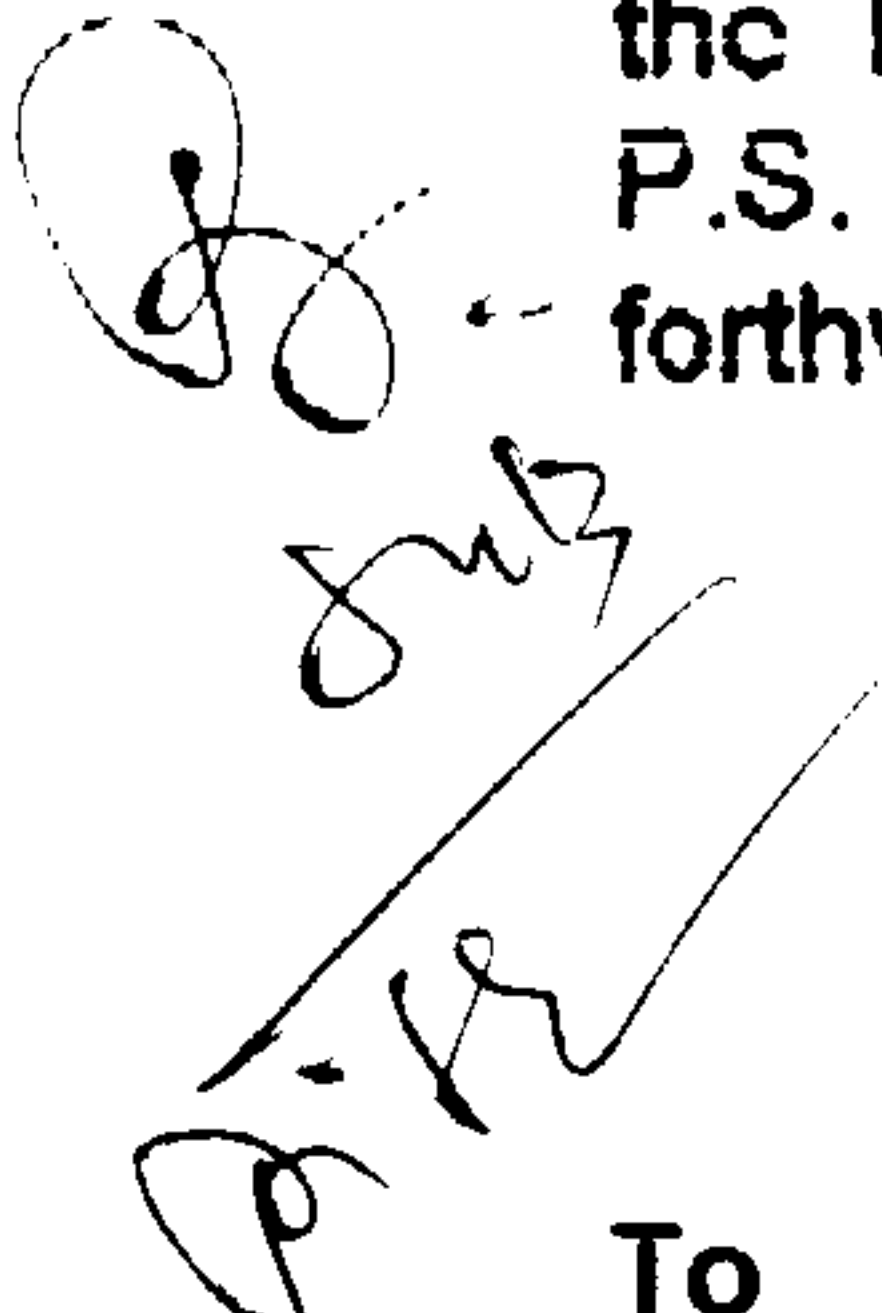
WHEREAS, a notice was issued vide reference 1st cited, calling the P.S. Palayam Vegetable, Fruits and Flowers Growers Co-operative Society Ltd., No.P.706 (hereinafter the "society") to state as to why the society should not be wound up under Section 126 of the Puducherry Co-operative Societies Act, 1972, as it is found that, the society was running on loss since 2006-2007 and there is no purchase or sales for the past six years and further there appears no scope for the survival of the society or for revival of its activities;

AND WHEREAS, in reply to the said notice, the Administrator of society, vide reference 2nd cited, has stated that, the society is remaining dormant, since the members are not evincing any interest in the existence of the society and sell their products through the society and therefore the Administrator has requested the Registrar for winding up of the society;

AND WHEREAS, in the light of the factual position stated above, I come to a conclusion that, the affairs of the society cannot be revived hence forth and therefore, there is no option except to wind up the affairs of the P.S. Palayam Vegetable, Fruits and Flowers Growers Co-operative Society Ltd., No.P.706;

NOW THEREFORE, in exercise of the powers conferred on me under Section 126 of the Puducherry Cooperative Societies Act, 1972, I hereby direct the winding up of the P.S. Palayam Vegetable, Fruits and Flowers Growers Co-operative Society Ltd., No.P.706, forthwith and communicate this order to the said society.
