ORDER:

WHEREAS, an order was made, vide reference cited, under sub section (1) of Section 126 of the Puducherry Co-operative Societies Act, 1972, directing the winding up of the affairs of the Pondicherry Public Servants Co-operative Stores Ltd., No.P.456;

AND WHEREAS, the financing bank viz, the Pondicherry State Co-operative Bank Limited was consulted in the matter of appointment of a liquidator, as required under sub-section (1) of Section 127 of the said Act;

AND WHEREAS, the Pondicherry State Co-operative Bank has stated that it has no objection for the appointment of a liquidator for the said stores.

NOW THEREFORE, in exercise of the powers conferred on me under sub -section (1) of Section 127, of the Puducherry Co-operative Societies Act, 1972, I hereby appoint Thiru. N. Pughazendhi, Co-operative Officer, as the Liquidator for the purpose of winding up of the said stores.

Thiru. N. Pughazendhi, Liquidator, shall take into his custody all the properties, effects and actionable claims to which the said stores is or appears to be entitled and complete the liquidation proceedings as per law.
