ORDER:

WHEREAS, the term of office of the committee of management of the
Pondicherry Vector Control Research Centre Staff Co-op. Credit & Thrift Society
Ltd., P. 402 is to expire on **31.03.2018;**

AND WHEREAS, the committee has to conduct election to elect a new
Committee before the expiry of its term;

AND WHEREAS, the President of the society, vide letter cited, stated that the
Committee of Management resolved to amend the Bye-Laws of the society to create
reservation for one post for members belonging to Scheduled Caste in pursuance of this
office instruction vide circular No.RCS/CLC/CIR/2011/127 dated 6.12.2011 and hence
the election could not be conducted to elect the new committee of management of the
society before expiry of its term, i.e., 31.3.2018. The society has sought permission for
extension of term for a further period of three months from 1.4.2018;

AND WHEREAS, I am satisfied that till such time the term of office of the existing
committee of the said society is to be extended;

NOW, THEREFORE, in exercise of the powers conferred on me under clause (b) of sub-section(5) of section 32 of Puducherry Co-operative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Co-operative Societies Rules, 1973, I direct the term of office of the committee of management of the Pondicherry Vector Control Research Centre Staff Co-op. Credit & Thrift Society Ltd., P. 402 be extended for a period of three months from 1st April 2018 to 30th June 2018;
