ORDER

WHEREAS the term of office of the committee of management of the Puducherry Public Works Department Staff Co-operative Society, No. P. 252 expires on 30.6.2015;

AND WHEREAS the committee has to hold election to elect a new committee before the expiry of its term;

AND WHEREAS the President of the society, vide letter cited, stated that, inter alia, the proposal to amend the bye-laws of the society relating to the constitution of the committee is under consideration of this office and hence election could not be held to install a new committee before the expiry of the term of the present committee. On the above premises, the committee has sought to extend the term for a period of three months;

AND WHEREAS in view of the above, I am satisfied that the term of the existing committee is to be extended;

NOW, THEREFORE, in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of Puducherry Co-operative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Co-operative Societies Rules, 1973, I direct the term of office of the committee of management of the Puducherry Public Works Department Staff Co-operative Society, No. P. 252, be extended for a period of three months, i.e., from 1st July to 30th September 2015.
