NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No.F.5/4/65-GP, dated 11th January 1965 of the Ministry of Home Affairs, Government of India, New Delhi, the Lieutenant Governor, Puducherry, is pleased to make the following amendments to the Government of Puducherry, Co-operative Department Group "C" Non-Gazetted and Non-Ministerial post of Junior Inspector of Co-operative Societies Recruitment Rules, 2014, notified vide G.O.Ms.No.7/Co-op., dated 17th July, 2014 and published in Part-II of the Extra ordinary Gazette No.32, dated 12th August, 2014, namely: -

1. *Short title and commencement.* - (1) These rules may be called the Government of Puducherry, Co-operative Department, Group "C" Non-Gazetted and Non-Ministerial post of Junior Inspector of Co-operative Societies Recruitment (Amendment) Rules, 2019.

(2). They shall come into force on and from the date of their publication in the Official Gazette.

2. *Amendment of rule-2.* - In the Government of Puducherry, Co-operative Department Group "C" Non-Gazetted and Non-Ministerial post of Junior Inspector of Cooperative Societies Recruitment Rules, 2014, for the existing rule 2, the following shall be substituted, namely: -

"2. *Number of posts, its classification and Level in the Pay Matrix* - The number of the said post, its classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) & (4) of the Schedule."

3. *Amendment of schedule.* - In the schedule to Government of Puducherry, Cooperative Department Group "C" Non-Gazetted and Non-Ministerial post of Junior Inspector of Cooperative Societies Rules, 2014, -

(a). In column 2, for the existing entries, the following shall be substituted, namely: -

48* (Forty Eight) [2019] * Subject to variation dependent on work-load

Sanctioned Strength - 40 posts

Deputation reserve - 8 posts

Total: 48 posts

(b). In column 4, for the column heading and entries relating thereto, the following column heading and entries shall be substituted, namely: -

"4 - Level in the Pay Matrix: Level-5"

(c). In column 10 -

(1). For the Note 1(a)(ii), the following shall be substituted, namely: -

"(ii) with 5 years regular service in posts in Level-4 of the Pay Matrix"

(2). The Note - 3 shall be omitted.
