ORDER

WHEREAS, an order was made, vide reference cited, under sub-section (2) of section 126 of the Puducherry Co-operative Societies Act, 1972, directing winding up of the affairs of Sri Bharathi Mills Staff Co-operative Credit Society Ltd. No.P. 391;

AND WHEREAS, to complete the winding up process of the said society, a liquidator is to be appointed under Section 127 of the Act;

AND WHEREAS, the financing Bank, viz the Pondicherry State Co-operative Bank was consulted in the matter of appointment of liquidator, as required under sub-section (1) of section 127 and the said bank has no objection for the appointment of liquidator to the said society.

NOW, THEREFORE, in exercise of the powers conferred on me under sub-section (1) of Section 127 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint Thiru N. Pugazenth, Co-operative Officer as the liquidator for the purpose of winding up of the said society.
